- 4. Matters Arising.
- 2742. Bench refurbishment. It was resolved to pay Mr Woodbridge a gross amount of £75.00 to cover his work and materials. Clerk to arrange.

2743 Highways.

- a. All concerns strimming, Lletyrneuadd Road and loose chippings addressed and completed.
- b. Road condition at Wauncorgam crossroads. The Clerk read out a letter from the County Council in which the damage is noted but apparently no major safety concern. As a minimum measure, the Council will fill out the area where the road edge has eroded and will install hazard marker posts around the vicinity. Also, as a secondary measure they will monitor the verge area for further settlements or movements. Noted.
