Minutes of the meeting held on Thursday 16th May, 2019.

- 2. Apologies: Cllrs T. Griffiths, A. Evans and H. Williams.
- 3. Minutes of last Meeting. Proposed correct by Cllr. Atkins and seconded by Cllr. A.L. Morgans.

4. Matters Arising.

- 2744. Footpath 25/09. Contracts have now been signed to fence off the footpath. County Cllr. to report back.
- 2747. Parking outside the school. It was reported that the PCSO had attended. County Cllr. is hoping that yellow no parking lines will be placed outside the school.
- 2749. Tarmac outside hall. It was reported that the Hall Committee have now received quotes for the work and are currently looking for available grants to assist with the costs. County Cllr. Jones reported that the AGM will be held on Monday 20th May and will report back to the June Council meeting.
- 2752. Clerk to write to Angela Burns AM. It was reported that the Green Party have become aware of the river pollution associated with Cwrtmalle.
- B4312 near collision. County Councillor reported that she had sent photos of the location to the County Council.

5. Correspondence.

2763. Independent Remuneration Panel Wales. The Clerk reported that the recent review published in February 2019 now updated the previous ones which stated that smaller (group C) could authorise payment to Councillors. It now states that Councils must make provision for the payments of £150 to Councillors with an option given to individuals to opt out by a declaration given to the Clerk.

One Voice Wales have forwarded standardised Opt Out forms with a summary form for use by Councils.

It was noted by Cllr. Carys Jones that the other Community Councils in her ward were also unsure of the way to treat the matter and, therefore, the Clerk was asked to contact One Voice Wales for guidance. The issue will then be discussed at the June meeting for final resolution.

7. Finance/ Approval of Payments.

2765. Annual Accounts. The Clerk presented the Annual Accounts and Governance statements which have been audited by LHP, the Council's auditors with no comments or corrections.

The accounts show a surplus of £7313 which is a reduction from the previous year reflecting the Council's decision in January 2018 to protect the community rate and to use its reserves for spending over and above the set budget on issues such as donations etc. as required.

The Council approved the annual accounts and the Chairman signed the necessary documents.

2766. Governance 2018-19. The Clerk reported that the procedures and arrangements for adequate governance entered on the annual summary were approved by the auditor and are in accordance with Council policies and risk management processes.
