2692 and 2699. Highways Matters.

A meeting was held on 24th October with the Clerk, Cllrs. J. Jones and R. Jeremy of Llangain C.C. and Messrs. J. McEvoy and Sion Lewis of C.C.C. at which various highways issues were discussed viz:-

- 1. Speeding through the village. It was agreed that two automatic traffic counters will be placed on the B4312 one near Cartref / Haulfryn and one beyond the Church Road / Penycoed junction (see attached map).
- 2. Church Road. Damage to hedge and Church wall. It was decided that the hedge did not form part of the highway and, therefore, any damage is the responsibility of the land owner. However, after further representations from the community council, it was agreed that a formal request be made for a steel type crash barrier to be placed on the hedge concerned. This request will now be logged on the County Council's infrastructure improvement programme (see attached plan).
