'Castell Gwyrdd' Community Farm (2783)

Minutes.

County Cllr. Carys Jones presented a report to the Community Council regarding the potential development of a community farm on land near Old Castle without any planning, licensing or any other necessary regulations.

Cllr. Jones spoke of her concerns for potential damage to vulnerable children invited to attend there and many other major concerns including misleading adverts. After a long discussion, it was resolved to support Cllr. Jones and express the council's own objections and concerns about having such an unregulated project in the area.

The Clerk was, therefore, asked to write a letter to the Chief Executive of Carmarthenshire County Council; Cllr. Emlyn Dole, Leader of CCC and to Cllr. Philip Hughes, Executive Board Member for Public Protection supporting Cllr. Jones and expressing their own objections. The letter would then be circulated to all members for their information.
