COUNCILLOR'S REPORT

WELSH GOVERNMENT/NATIONAL RESOURCES WALES INITIATIVES CONTROL OF AGRICULTURAL POLLUTION REGULATIONS

The recent Written Statement by Leslie Griffiths establishes baseline standards for good practice which will be introduced from 1st April 2021. Please visit :

The recent Agriculture (Wales) Bill White Paper is inviting contributions to its consultation.

Nitrates policy may place the whole of Wales in a Nitrate Vulnerable Zone and is likely to cause disruption within the farming community. The prohibition on spreading slurry for five months in the year is likely to compound local problems experienced due to the volume of slurry from the superfarms, and incur prohibitive costs to small/medium farms. Further details to come.

The recent Special Areas of Conservation Phosphate Compliance Report is likely to impact on most planning applications. Phosphate impact assessments will be necessary as part of the planning application process - there is no detail as yet on how widely this legislation will be applicable.

INDUSTRIAL FARMING TASK FORCE

Next week I have a virtual meeting of the Task Force with Mr and Mrs Richards, Cwrt Malle. The agenda will include status of Planning Consents at Wernolau, any new structural development, slurry separation installation, traffic reduction targets, and responses to NVZ and Phosphate directives.

FFERMIO FORUM

The forum will meet next week with a representative of NRW. We look forward to a constructive session focusing on issues related to pollution and environmental enforcement.

SKY FILMS

A Sky Film 'The Loneliest Boy in the World' will be filmed in Ferry Point and Llansteffan village next week. The crew will be arriving on March 2nd (date not confirmed) and filming is expected to last 3 to 4 days. The cast/crew may be staying in accommodation locally including Llangain. Such accommodation has been authorised for use under Covid-19 restrictions, and the company's activities are heavily regulated.

SAFE ROUTES IN COMMUNITIES

The Safe Routes In Communities (SRIC) grant application for Llanybri has been submitted to Welsh Government which underlined the case for highway/driver safety and improvements in our community. The benefits of elements of this grant, if successful, will be also be seen in Llangain and Llangynog.
