- 3. Appointment of Chairman. It was proposed that the present Vice- Chair, Cllr Haydn Williams be appointed to serve as Chair for the year commencing May 2021. Cllr. Williams accepted the office and signed the necessary declaration. The outgoing Chair, Cllr Jeremy thanked the Clerk, Mr Iwan Griffiths for his advice and support and arrangements during the difficult times during the Covid19 outbreak and lockdown.
- 4. Appointment of Vice-Chair. It was proposed and seconded that Cllr Carl Atkins be appointed to serve as Vice Chair during the coming year.
- 5. Appointment of Clerk and Responsible Financial Officer. It was resolved that Mr I. Griffiths continue in the post.
- 6. Appointment of Internal Auditor. It was resolved that LHP continue as the Council's auditors.
- 7. Appointment of members to attend One Voice Wales meetings. Any member available.

The Clerk reported that he had completed the annual accounts for 2020/21. The accounts now show a surplus of £9820 which is an increase of £1810 from the initial figure from the 2019/20 amount.

The increase is due to the £585 unspent amount in respect of out of date cheques which the Audit Wales ruled should be added to the initial figure. The other £1225 is an underspend mostly due to the fact that the Community Council did not undertake much financial activity due to the lockdown.

As the Clerk has outlined previously, most of such a surplus should be identified for future spending on specific projects. Regarding this, the Council resolved that the money should be kept for the Milestone project, the potential need for replacement of noticeboards etc. and match funded projects.

The Council approved the accounts and thanked the Clerk for his work.

The Accounts will now be signed by the Chair and forwarded to LHP for audit and subsequently to Wales Audit for final approval.
